## **Share buyback – 27th Interim Reporting**

In the time period from and including 22 September 2025 until and including 28 September 2025, a number of 431,168 shares of Siemens Healthineers AG were bought back within the framework of the share buyback of Siemens Healthineers AG; on 19 March 2025, Siemens Healthineers AG disclosed pursuant to Art. 5 para. 1 lit. a) of the Regulation (EU) No. 596/2014, as last amended by Regulation (EU) No. 2024/2809 (MAR) in conjunction with Art. 2 para. 1 of the Delegated Regulation (EU) No. 2016/1052 the start of the share buyback on 24 March 2025.
